Data privacy officers need a simple way to gain visibility into an organization's regulatory compliance posture in near-real-time, while being able to act efficiently on policy exceptions and data remediation tasks. Tools that provide these capabilities in an agile and non-invasive manner are critical to the successful compliance with PII laws and the effective protection of data.

The integrated solution supports the complete requirements of a data privacy compliance program, while ensuring the effective use and monetization of data across the enterprise.


First, Data Sentinel leverages the Denodo Platform to access hundreds of internal and external data sources for sensitive data discovery and classification, both on-premises and across all clouds. Data Sentinel's Automated Data Mapping can discover, classify and generate risk ratings on all types of sensitive data elements, including personally identifiable information (PII), protected health information (PHI), payment card industry (PCI) data, and more, all within a customizable data privacy framework. Additionally, Data Sentinel provides reporting and incident management as required by compliance regulations.

Then, Data Sentinel's data classifications and risk ratings are imported into the Denodo Platform and appear to users in the Denodo Data Catalog. From Denodo, data access can be effectively managed based on sensitivity and risk, and sensitive data can be de-identified as needed, in a no-code fashion, consistently across all of an organization's systems. A user could, for example, automatically restrict access or de-identify a given PII dataset with masking rules, across all instances and tools, based on the sensitivity classifications that have been applied to the data.

The integrated solution supports a broad spectrum of compliance and data access objectives including data mapping, secured data access, data masking, privacy impact assessments (PIAs), data subject access requests (DSARs), and the establishment of records of processing activity (RoPAs). The data privacy officer's needs of ensuring privacy compliance and data security are met, while also enabling data consumers to access their data rapidly, safely and securely.
